

ADVANCED DIPLOMA IN INTERNATIONAL BUSINESS MANAGEMENT PART TIME COURSE

Objectives: This course aims to empower participants with sound knowledge and skills in the management of business operations to cope with the ever-changing business environment. Participants will be exposed to a full range of management skills that is useful to succeed in today's business environment. This course is ideal for participants who wish to advance in their career or for those who wish to learn more about business management. Graduates of the Advanced Diploma in International Business Management course are equipped with the pre-requisites needed for the perusal of a formal undergraduate education in Business Management.

Course Duration: Part time course consists of 16 modules. All modules will be completed within 15 months

Pre-requisites:

Age : 16 years old & above

Academic entry requirements: Relevant SCI Diploma or others PEIs Diploma or at least 12 years of formal education *others PEI diploma will be based on a case by case basis to the academic level requirement.

Language Proficiency: English Language with IELTS 5.5 & above; or at least C6 in GCE O Level English; or passed the language proficiency test of SCI or equivalent

Diploma from SCI or other recognized local/overseas Institutions. (Students who have prior studies from other institutions are required to provide original certificates of completion. The Academic Board may grant students exemptions from some modules.)

Course Completion & Certification:

Local students (Singaporeans & PR) and students with Dependent Pass, attendance must not less than 75% and not absent • for more than 7 days in a row.

Upon completion of the 16 modules, those who fulfill the required attendance and pass all the assessments will be awarded an Advanced Diploma in International Business Management certificate by SCI.

Mode of Assessment:

Internal Assessment: This course is assessed by written Assignments 50% & written examinations 50%.
