

DIPLOMA IN INTERNATIONAL BUSINESS MANAGEMENT (MANDARIN) PART TIME COURSE

Objectives: This course aims to empower participants with sound knowledge and skills in the management of business operations to cope with the ever-changing business environment. Participants will be exposed to a full range of management skills that are useful to succeed in today's business environment. This course is ideal for participants who wish to advance in their career or for those who wish to learn more about business management. Graduates of the Diploma in International Business Management course can proceed to the Advanced Diploma in International Business Management course.

Course Duration: Part time course consists of 8 modules. All modules will be completed within 9 months.

Course Modules: The 8 modules are:-

1. DIBM 101 Business Law & Ethics; 2. DIBM 102 Business Statistics; 3. DIBM 103 International Economics;
4. DIBM 104 Organizational Behaviour & Culture; 5. DIBM 105 Principles of Accounting; 6. DIBM 106 Principles of Information Systems; 7. DIBM 107 Principles of Management; 8. DIBM 108 Principles of Marketing

Pre-requisites:

- Age : 16 years old & above
- Academic level: Obtain at least C6 in any 5 GCE O Level subjects or At least 10 years of formal education (particularly China, Indonesia, Thailand & Japan), or equivalent or pass the placement test of SCI.
- Language Proficiency: 9 years of studying in a Chinese school or C & above in O Level Chinese or equivalent or Pass in SCI language proficiency test.

Course Completion & Certification:

Local students (Singaporeans & PR) and students with Dependent Pass, attendance must not less than 75% and not absent for more than 7 days in a row.

Upon completion of the 9 modules, those who fulfill the required attendance and pass all the assessments will be awarded a Diploma in International Business Management certificate by SCI.

Mode of Assessment:

Internal Assessment: This course is assessed by written Assignments 50% & written examinations 50%.
