 - Your valid Passport
 - Your valid Dependant's Pass (DP), if any, and the valid main work pass to which the DP is linked
 - Your valid Immigration Exemption Order (IEO), if any
 - Both Parents' valid Passports or Singapore NRICs/Re-entry Permits
 - Caregiver's Singapore NRIC/Re-entry Permit if parent is not working in Singapore or on Long Term Visit Pass
- 4 Due to limited vacancies for international students, the school will only hold the school place up to 28/02/2022, unless there are extenuating circumstances due to COVID-19. We will not consider any request for a different school posting or subsequent transfer to another school for successful applicants who accept the offered schools.
- 5 If you are not a DP or an IEO holder, you will need a Student's Pass (STP) before you will be allowed to start school. Please apply for an STP at the Immigration & Checkpoints Authority (ICA) after reporting to school. Please note that acceptance into our schools does not guarantee the issuance of an STP.
- 6 We wish you all the best in your studies.
